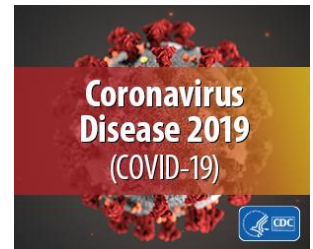

Topic: Residential Provider Food Support

Information:

MDHHS released some information this morning and then clarified the process later today. Residential providers that need assistance obtaining food supplies can contact local bulk food suppliers.

The clarification from MDHHS directs providers to directly contact bulk food suppliers. No coordination is required of the Emergency Managers and recommended best practice is to only reach out to the local Emergency Managers as a last resort.

This communication seeks to clarify the earlier notice about assistance for Adult Foster Care (AFC) Homes who are having difficulty getting adequate amounts of food due to restrictions on bulk buying.

Please inform the AFCs that the distributors, Gordon Food Service, Sysco and others have ample food and that the home itself should be reaching out directly to them. If in some rare cases, distributors are not available, then the homes should be talking with the retailers directly, preferably prior to just showing up, and try to make arrangements for purchasing food.

For the rare situations where distributors are not available, and even rarer that they reached out to their local retailer and have still been denied, then and only then would they reach out to their local emergency manager for assistance. Please do not contact the local emergency manager for making the initial connection to the food distributor or retailer. Only contact the local emergency manager in situations where an AFC had exhausted all means of trying to obtain adequate food and have been unsuccessful. The local emergency manager is not able to make the initial connection to the distributor and numerous calls to them are preventing them from being able to address other needs.

RE: Residential Provider Food Support

The State Emergency Operations Center, in cooperation with the District Coordinators of Emergency Management and Homeland Security Division of the Michigan State Police, have established a protocol to assist in addressing the difficulties that Adult Foster Care (AFC) Homes are having accessing adequate amounts of food due to retail bulk buying restrictions.

AFC Homes that are having difficulty with obtaining food for their residents are encouraged to contact their local emergency manager and explain the situation to them. The emergency manager will connect the AFC with a food service distributor, such as Gordon Foods or Sysco, to review the needs of the home and determine how they can assist. These distributors have bulk items and the ability to provide larger quantities of food at a time.
